### ACTION List

Tell them this:

1. **NO to the health insurance exchanges**—either state-based or otherwise. *Insurance exchanges, state-based or otherwise, are a key component of the Patient Protection and Affordable Care Act ("ObamaCare"). No insurance exchanges = no ObamaCare!*
2. **NO to any expansion of Medicaid in the state of Oklahoma**—*The country is broke and we cannot afford this!*
3. **Terminate the Oklahoma Health Information Exchange Trust (OHIET)** - *This unelected entity is busy working to establish and implement the foundations that make "Obama Care" work. This unelected body has no legislative oversight and is not accountable to the People of Oklahoma—they do not represent the interest of the people!*
